

Tax Installment Payment Plan T.I.P.P.



T.I.P.P. is a monthly tax installment payment plan by which taxpayers may make consecutive monthly payment for taxes rather than a single annual payment.

Your most recent annual tax levy is divided by 12 to establish a monthly payment amount. Payment amounts will be adjusted in May or June to compensate for changes in taxes resulting from the annual tax levy. Payments begin January 1st of the new year and continue for 12 consecutive months.

You may withdraw from the plan by giving notice in writing before the 1st day of the month preceding the next payment date.

If your property is sold, title transferred or you have a change in bank account information, it is the responsibility of the participant to inform the Tax Department in writing. We require the notice of change before the 1st of the month prior to the next withdrawal.

I/We authorize the County of Wetaskiwin to debit my account listed below.

This authorization allows the County of Wetaskiwin to adjust my/our monthly payments as required to ensure my/our annual property tax levy is current by December 31 of each tax year (January 1- December 31).

The treatment of each payment shall be the same as if I/we had personally issued a cheque authorizing payments indicated and to debit the amount specified to my/our account.

Pursuant to **Fees and Charges Bylaw Schedule A** all payments returned NSF will be subject to a \$25.00 service charge. Regular collection shall apply to any returned payment. Once NSF payment occurs, this contract may become NULL and VOID and the customer will return to standard method of billing.

I/We understand that any amounts owing to the County of Wetaskiwin must be cleared PRIOR to commencement of pre-authorized withdrawal program.

Either party may cancel this authorization agreement at any time in writing. The authorization agreement will be terminated, providing written notice is received by the 1st business day of any month. (ie. notice must be received on or before June 1st to remove the June installment). The land owner must notify the County immediately following the sale of the property.
