

# ORDER BY THE COUNCIL OF THE COUNTY OF WETASKIWIN NO. 10

Pursuant to the authority granted under the provision of the Road Protection By-Law 2021/10 the Council of the County of Wetaskiwin No.10 orders that effective **10:00 a.m., March 30, 2026**, the following maximum allowable weights will be permitted on local roads in the County of Wetaskiwin No.10:

Rge Rd 240 from Hwy 613 to Twp Rd 462A (0.8 km)	100%
Rge Rd 240 from Hwy 613 to Twp Rd 460 (G3 Road) (3.2 km)	100%
Twp Rd 454 from Hwy 22 to Rge Rd 65 (1.6 km) & south on Rge Rd 65 for 0.8 km	100%
Twp Rd 460 from Hwy 2A to Rge Rd 240 (3.4 km) (G3 Road)	100%
Twp Rd 460 (Rose Ck Rd) from Rge Rd 74 west to County boundary (3.2 km)	100%
Twp Rd 470 from Hwy 22 to Rge Rd 65 & Rge Rd 65 north of Twp Rd 470 (1.2 km)	100%
Within the Hamlet of Winfield between Main Street for 50 metres in a north-eastern direction to the connecting laneway between 1 <sup>st</sup> Street E and 1 <sup>st</sup> Street W	100%
Within the Hamlet of Buck Lake from Rge Rd 63 east to the Bridge at Rat Lake (1.0 km)	100%

### **Exemptions:**

- Vehicles and equipment required by the County of Wetaskiwin No. 10.
- Vehicles and equipment in possession of a valid Permit issued by the County of Wetaskiwin.
- Emergency vehicles & essential services as defined in the Traffic Safety Act.
- Farming Industry ~ one increment above any posted ban year-round (without a permit)

### **Note:**

Any permit issued by the County of Wetaskiwin or Roadata Services Ltd (RDS), shall be considered null and void in the event the Permit Holder has violated any of the terms and conditions contained within the Permit. Any permit issued by the County of Wetaskiwin does not absolve the Permit Holder or operator from responsibility for any damages caused to the Roadway as a result of travel pursuant to the permit.
