Title Recreational Units During Family Functions

1. Policy Statement:

1.1. Council wishes to accommodate Family Functions including reunions, weddings, and other similar family functions and that associated temporary use of Recreational Units be allowed during these functions on a given property.

2. Responsibilities:

2.1. The Development Authority shall approve or deny all requests.

3. Guidelines:

- 3.1. Applications shall only be allowed within properties districted as Institutional (IS), Recreational (R), Watershed Protection (WP), Wizard Lake Watershed (WLW), Agricultural (AG), and Residential, excepting Urban Residential (UR), Mobile Home (MH), and High Density Rural Residential (HDR) Districts.
- 3.2. The use or function shall be temporary, up to a maximum of ninety-six (96) hours or four (4) days.
- 3.3. The use or function on a parcel shall only occur a maximum of two (2) times per year; however, further requests can be allowed at the discretion of the CAO.
- 3.4. Where a dwelling exists on a parcel of land under one (1) acre, a maximum of five (5) Recreational Units may be present.
- 3.5. Where a dwelling exists on a parcel of land between one (1) and two (2) acres, a maximum of ten (10) Recreational Units may be present.
- 3.6. Where a dwelling exists or does not exist on a parcel of land between over two (2) acres and less than twenty (20) acres, a maximum of twenty (20) Recreational Units may be present.
- 3.7. Whether a dwelling exists or does not exist on a parcel of land twenty (20) acres or greater, a maximum of thirty (30) Recreational Vehicles may be present.
- 3.8. The use or function must abide by all Municipal, Provincial, and Federal legislation, including, but not limited to the County's Noise Bylaw and regulatory requirements for the disposal of wastewater.
