**A Public Hearing** will be held on December 17, 2024 at 10:00 a.m. All Public Hearings are open to the public and attendance either in person or virtually is encouraged. Written and verbal comments may be given at the Public Hearing.

## Purpose of the Public Hearing:

The Council of the County of Wetaskiwin No. 10 is proposing to adopt a new Land Use Bylaw (LUB). The new LUB will replace the existing Land Use Bylaw 2017/48.

The purpose of the Public Hearing is to allow the public to address Council directly on the proposed new LUB. The significant changes from the existing LUB to the new LUB include reducing the number of districts from over thirty (30) to ten (10), supporting economic development by easing regulations and making more uses permitted in each district, providing greater flexibility in housing types and allowing up to two (2) dwelling units on all residential lots, simplifying recreational unit regulations, and increasing the variance abilities of Development Officers in order to support unique and innovative developments. The Bylaw also streamlines development approvals, removes redundancy, and is easier to read and use by all audiences.
