
## Secondly

*Meridian 4 Range 23 Township 46 Section 34 Quarter North East, All that portion of original government road allowance intersection adjoining the north east corner of NE 34-46-23-4.* 

## Thirdly

Meridian 4 Range 23 Township 48 Section 35 Quarter North West, All that portion of original government road allowance which lies south of a line drawn at right angle to the north east corner of Lot 1 Block 1 Plan 0624490 and north of a line drawn at right angle to the most easterly south east corner of Lot 1 Block 1 Plan 0624490, containing 8.75 acres more or less.
