# 2025 Residential Solar Installation Grant Application

The County of Wetaskiwin received an anonymous donation of \$65,000 to support the Solar Installation Grant program. This initiative aims to assist residential property owners in accessing grant funds for installing a solar PV system, ultimately reducing their electricity expenses. Qualified applicants can receive \$6,500 to install a minimum 5kW solar PV system on their property, covering both the purchase and installation costs with the awarded grant money.

The Society for Joint Economic Development Initiatives (JEDI) will manage the grant program on behalf of the County, as its economic development provider.

Before you submit your application, please take a moment to read the following information.

### Pre-Approval:

- Please submit this application to determine your eligibility for the Solar Installation Grant Program.
- To obtain pre-approval, you must include a quote for a minimum 5kW solar PV system along with your application.

# **Grant Approval & Payment:**

- Before proceeding with the installation of the solar PV system, it's necessary to obtain a development permit (if ground mounted) and building permit (if roof mounted). - Prior to the disbursement of the grant, a final electrical inspection of the system is required by Superior Safety Codes in Edmonton 780-489-4777 or Red Deer 403-358-5545. The inspection report should specify the system's size and must be dated on or after April 22, 2025, to qualify for the grant.
- Individuals are limited to one application for the program, even if they own multiple properties within the County of Wetaskiwin.
- The County reserves the right to refuse any grant application if it determines that the proposed project does not align with the vision and objectives of the program.
- The County reserves the right to request additional details or conduct an inspection of the system before making payments.
- All sections of the application, including a quote, must be completed. Incomplete applications may not be considered.
- Existing systems or expansions are not eligible.

#### **Deadlines:**

Applications will be accepted from Earth Day, April 22, until May 8 at 4:30 p.m., by email or in person.
 All complete applications—including a quote for a new 5kW+ system—will be reviewed following the May 8 deadline. Grants will be awarded on a first-come, first-served basis to eligible applicants with

complete submissions. Existing systems or expansions are not eligible, and incomplete applications will not be considered.

- The application for approval and payment of the Solar Installation Grant must be completed within eight months of receiving pre-approval notification.
- Extensions may be considered if the project has commenced but requires more than eight months for completion, provided that evidence of commencement is provided to the County of Wetaskiwin.
- Failure to provide evidence of project commencement may result in the grant funds being awarded to another applicant.
